

LIMITED RELEASE OF COPYRIGHT

[For Use With New Articles to be Published On or After January 1, 2021]

Recitals:

1. I am the holder of a copyright ("Copyright") with respect to an article created by me titled _____ ("Article") submitted by me with this instrument for publication in the CIVIL WAR PHILATELIST ("CWP").
2. The CIVIL WAR PHILATELIC SOCIETY, INC. ("CWPS") intends to digitize the print copies of CWP and to make digital copies available to its members on its web site, and/or, at its sole discretion, to other individuals and/or entities as CWPS from time- to-time determines.
3. I desire to have the widest possible readership for my Article and, accordingly, want to have my Article included among those to be published by CWPS in CWP print format and in digital format, and made available, as stated above, for reading, copying and/or downloading.
4. I have been advised that if I do not grant this LIMITED RELEASE OF COPYRIGHT ("LIMITED RELEASE") to CWPS that my Article will not be published in CWP in either print or digital format.
5. I understand that CWPS will rely upon receiving this LIMITED RELEASE (among other factors and considerations) in making a determination to publish my Article, but that CWPS will not be required to publish my Article merely because it has received and accepted this LIMITED RELEASE. CWPS retains all decision rights to publish or not publish the Article.
6. I acknowledge that CWPS will rely on this grant of LIMITED RELEASE if it publishes my Article.

GRANT OF LIMITED RELEASE:

- A. In consideration of the foregoing, I authorize CWPS to include my Article among those it publishes in CWP in both print and digital formats, and makes available, as stated in the above Recitals, such availability to be on such terms and conditions as CWPS might in its sole discretion from time-to-time determine.
- B. I grant this LIMITED RELEASE without payment of any kind required to be made to me by CWPS or any other entity or any individual.
- C. I represent and warrant that (i) I am the sole owner/holder of the Copyright, and (ii) I have not granted or promised the rights described in this LIMITED RELEASE to any other person or entity. I will hold CWPS, its trustees and officers, and CWP's Editor harmless from any costs or damages it or they might incur (including attorney's fees and disbursements) by reason of any claim made in contravention of this representation and warranty.
- D. This LIMITED RELEASE is solely for the purposes stated in the Recitals above, and for no other purpose whatsoever. I retain all other (and do not grant or release) any other rights and benefits to my Copyright not expressly set forth in this LIMITED RELEASE.
- E. The duration of this LIMITED RELEASE shall be for the term of my Copyright. I may not revoke this LIMITED RELEASE.

By signing this LIMITED RELEASE, the undersigned agrees to be bound by its terms and conditions, and agrees that CWPS may rely upon its terms and conditions as set forth above.
